THE FOLLOWING EQUIPMENT IS AVAILABLE TO YOU WHETHER YOUR SUPERVISOR REQUIRES YOU TO WEAR IT OR NOT.

CLOTHING PROTECTION

• Lab coats may be ordered through supervisors.

EYE PROTECTION

- Safety Glasses, plastic (including side shields and case)
 Issued for work in a machine shop area, or when working on infrared lasers.
- Splash Goggles, plastic
 Issued when working with liquids (not to be used with any kind of laser).
- Safety Glasses /Goggles for use with lasers
 Contact the Radiation Protection Office, 20C-207, x3-2180, for advice on required custom made filtered
 glasses and on laser environmental safety.
- Prescription Safety Glasses
 Issued to all personnel requiring safety glasses in their work areas.

Procedure:

- 1. Obtain safety glasses order form and requisition from Matt Fulton, NW21-214, x3-8917. (This will pay for the glasses, not the examination.)
- 2. Take order form to personal eye doctor for completion, i.e., MIT Optical Shop in MIT Student Center will complete form for approximately \$20.
- 3. Present completed form and requisition to your supervisor and have the supervisor approve by signature on the requisition.
- 4. Return completed form and requisition to Matt Fulton, NW21-214, x3-8917.
- 5. This requisition will be mailed to the MIT EHS Office, E19-207. This Office will place an order for the glasses with American Optical or Fendall.
- 6. Any adjustments to the glasses must be obtained and paid for by the individual. (If Tech Coop Optical Shop completed form, they will provide this service free of charge.)

FACE PROTECTION

Face Shields

Face Shields are issued to employees performing certain chemical procedures and when welding.

FOOT PROTECTION

· Safety Shoes

Issued to employees when his/her supervisor and/or the Safety Committee feel it is desirable for employee to wear safety shoes while on the job.

Conditions of Reimbursement for Safety Shoes:

- 1. Person seeking reimbursement works in a lab environment.
- 2. One pair of shoes per person per year.
- 3. Reimbursement will amount to the cost of the shoes or \$90 (whichever is less) once a year, or \$180 once every two years.
- 4. Shoes must have ANSI or OSHA number stamped inside.
- 5. Shoes and receipt must be brought to Nancey Masley, NW21-215 or Matt Fulton, NW21-214, for approval before reimbursement can be made.

- Several types of protective gloves are available through MIT's Partner Company, VWR Scientific, x3-1881, 18-B90.

 Issued to employees who work in areas in which there is a potential for head injury by falling/swinging objects or limited head room.

LUNG-RESPIRATORY PROTECTION

Respirators: All Types
 Issued through the Industrial Hygiene Office, N52-496, x3-2596, after successful completion of a
 "Respirator Qualification Test" (test given by Jackie Sherry) and associated Respirator User Training.

RADIATION MONITORING

• Film Badges and Dosimeters
Radiation badges are issued by the Radiation Protection Office after the employee completes radiation training.
